October 2019 meeting of the Osteopathy Board of Australia

The 117th meeting of the Osteopathy Board of Australia (the Board) was held on 25 October 2019 in Melbourne. The Registration and Notification Committee (RNC) also met on the same day as the Board meeting.

The Board publishes this communiqué on our website and emails it to a broad range of stakeholders. At each meeting the Board considers a wide range of issues, many of which are routine and are not included in this communiqué.

Osteopathic International Alliance

The Board's Chair, Dr Nikole Grbin, attended the annual Osteopathic International Alliance (OIA) meeting in Frankfurt, from 4 to 6 October 2019, joining attendees from osteopathic organisations and education institutions from around the world.

Osteopathy regulation, education, research and association leadership were main themes of this years' conference which also gave regulators the chance to discuss areas of mutual interest including common regulatory functions and emerging issues.

Another focus of the conference were the strategic objectives of the World Health Organisation Traditional Medicine Strategy (2014-2023) which are supported by the OIA. These three collaborative projects and their associated task forces are benchmarks in practice, update on the global profession (global survey) and glossary of osteopathic terms. Osteopathy clinical advisers

The Australian Health Practitioner Regulation Agency (AHPRA) is advertising <u>osteopathy clinical advisor</u> <u>roles</u>.

The positions will be available in any location and are flexible in nature. The clinical advisor will contribute to a risk-based approach by giving AHPRA staff a clinical input into notification, compliance and registration matters.

Role duties include:

- giving clinical input to AHPRA staff on case management
- reviewing briefing information sent to external parties

- reviewing responses from practitioners, and
- helping AHPRA staff understand and interpret clinical material.

The closing date is **Thursday 7 November 2019** at 5pm AEST.

Registration renewal due by 30 November

Osteopaths wishing to renew their registration on time must do so by 30 November 2019.

More than 2,500 osteopaths hold general, specialist or non-practising registration with the Osteopathy Board of Australia (the Board). The guickest and easiest way to renew is <u>online</u>.

Practitioners who do not apply to renew their registration by 31 December 2019 will have lapsed registration. They will be removed from the **Register of Osteopathic Practitioners** and will not be able to practise their profession in Australia.

Renewal applications received in December will incur a late payment fee in addition to the annual renewal fee. This is outlined in the Health Practitioner Regulation National Law, as in force in each state and territory.
